

### ***344<sup>th</sup> Military Intelligence Battalion - "Silent Sentinels"***

The mission of the 344th Military Intelligence Battalion is to train Soldiers to be Military Intelligence and Cyber professionals. Upon graduation, these Soldiers are tactically and technically competent, disciplined, physically fit, instilled with Army values, and ready to join the Joint Team.

It prepares Soldiers to fight our Nation's wars while taking care of them and their Families. The battalion trains Soldiers in three different Military Occupational Specialties, Military Intelligence, and Cyber. It has more than 70 classes in session at any given time across over 40 blocks of instruction and three separate Companies. The battalion has more than 150 permanent party members with an annual student throughput of about 1,500 Soldiers.

#### **REPORTING**

During Duty Hours: All Soldiers will report to the BLDG 409, 340th Fort Lancaster AVE in the ACUs. After Duty Hours: All Soldiers will report to the SDNCO in bldg 251 in the ACUs. Soldiers must report no later than 2359 of the report date. Soldiers who are in TDY status may report NET 0830, the Friday before class report date. All Soldiers coming to Goodfellow for training must bring a copy of their DD Form 93 (Record of Emergency Data), a copy of their SGLV Form 8286 (Service Members Group Life Insurance), and current orders 1610's.

#### **ALL TDY SOLDIERS MUST HAVE AN ACTIVE GOVERNMENT CREDIT CARD**

Government lodging (the Angelo Inn) is available for all Soldiers in a TDY status. Per diem, meal rates, and related information is available both on the corresponding ATRRS Course page and on the Joint Travel Regulation (<https://www.travel.dod.mil/Travel-Transportation-Rates/Per-Diem/Per-Diem-Rate-Lookup/>). Please consult with your unit's Travel and Finance Officials to ensure that all appropriate travel orders and authorizations are completed prior to arrival to Goodfellow AFB. 344th Military Intelligence Battalion does not provide Travel Orders (DD Form 1610), MFRs, or anything not already-listed on ATRRS for incoming Soldiers.

Married Soldiers on Permanent Change of Station (PCS) may bring their Families if their orders authorize it. Those married Soldiers who are authorized to bring their Families may reside in housing on-base. Soldiers should be aware that on-base housing is limited when determining if they should bring their Families. If on-base housing is unavailable, Soldiers are authorized off-base housing.

35N MOS-T RA, ARNG, and USAR students: IAW ALARACT 011/2022, RA, ARNG, and USAR Soldiers with dependents at location other than San Angelo, Texas must qualify for and submit a BAH G1 waiver to obtain BAH at dependents location. Otherwise, MOS-T RA, ARNG and USAR 35N students will receive BAH at the San Angelo rate. Recommend waiver be submitted at least one month prior to class start date.

**QUARTERS:** Government Barracks are available and directed for IET Soldiers. IET Soldiers are not authorized to bring dependents.

**MESS:** A government dining facility is available and directed seven days a week. The dining facility is an a la carte system. Soldiers will be reimbursed at the standard government rate.

**UNIFORM:** Soldiers must bring all their initial issue items (see APP E, AR 670-1). Soldiers will wear the Army Service uniform for graduation. Civilian clothing is optional and dependent on phase privilege for off-duty wear.

**CLEARANCE:** Soldiers attending 35N/35P/35S training are required to have a completed National Agency Check (NAC) and interim or fully adjudicated TS/SCI clearance to begin training. Soldiers without a completed NAC will not be scheduled for training. Soldiers without an interim or fully adjudicated TS/SCI clearance will not be scheduled for training. Any Soldier reporting without an interim clearance may be returned to their parent or losing unit. Soldiers who do not will be placed on hold status, or reclassified into a new MOS. MI Branch Soldiers are required to receive and pass a counterintelligence scope polygraph (CSP) prior to being awarded the MOS and must continue to pass subsequent CSPs to hold the MOS. Effective November 2023, IAW DA PAM 611-21, a fully adjudicated TS/SCI clearance along with CSP polygraph is required to award the MOS.
